**10-Day Money-Back Guarantee:**

Within 10 days of delivery of a shipment, you may return unopened and unused items you purchased from us, for any reason, for a refund of your purchase price. If the return is necessary as a result of our error, we will issue a full refund including shipping cost.

This warranty does not cover damage due to negligence, misuse, accident or abuse. Any claim due to damage for appearance defects will not be honored once the wheel has been mounted with a tire or if the wheel has been sold as "used" or "defective" product. **Return Policy**

You must call to request a return authorization prior to shipping the product back to us. No returns will be accepted without prior authorization from BZO Wheels and complete the Merchandise Return Authorization Form (RMA Form). All claims require the ORIGINAL packaging materials, and a copy of the original invoice. We will not accept any return without original invoice.

Products may be returned for credit without handling/restock penalties within 10 days of delivery of a shipment, 11-30 days with a 5% handling/restock charge, 30-60 days with a 10% handling/restock charge, 60-90 days with a 20% handling/restock charge, and products older than 90 days are not returnable. Shipping/delivery charges will not be credited on any sale.

All returns must fall under the following guidelines: Product must be new and in unmounted condition, product must be in original packaging, all accessories must be present and securely packaged. Except warranty rims, mounted wheel and tire packages are not returnable. Products designated as special order or discontinued are not returnable under any circumstance. All return shipping/delivery must be prepaid.

Credit is issued to the respective customers account for future purchases only.
